This Addendum modifies the original Request for Proposals as noted below and shall be incorporated into the Contract Documents. All other provisions of the RFP CET 21-1, released February 4, 2021, not already modified by any addenda previously issued, shall remain unchanged.

Sections 1.28, 1.29 and 1.30 are revised to the following:

Proposers are encouraged to submit questions in writing to dorr@coic.org prior to the conferences. The purpose of the Pre-Proposal Conference is to answer questions and provide clarification regarding the RFP and to help ensure COIC’s receipt of thorough responses to the RFP that are prepared using the same base assumptions. A record of attendance will be conducted. COIC intends to provide addenda to the RFP to those firms who have either attended in the pre-proposal conference or registered for this procurement by simply emailing interest in the solicitation to the Transportation Fiscal Administrator at dorr@coic.org
