The July 28 guidance from the governor established metrics for reopening that did not permit COIC to implement the Hybrid mode; the November 4, 2020, metrics still did not permit Hybrid implementation. Nonetheless, the basic cohorting elements of the Hybrid continued to be adapted to Limited In Person Instruction (LIPI) - Comprehensive Distance Learning (CDL) until the situation in Oregon and Deschutes County met the governor's criteria for student and staff safety in January, 2021, that allowed each district to determine how to return students to the classroom.

Distance Learning Adaptation to Hybrid Plan
October 29, 2020**

Overview

- 1) COIC uses Odysseyware and AZTEC Learner Management Systems (LMS) and teacher produced packets and videos as part of the synchronous teacher-facilitated learning. Synchronous opportunities are provided daily by means of scheduled Zooms, phone calls, texts, and emails for each of the 13 cohorts.
- 2) Odysseyware has adaptations for students including the text aloud, a variety of language translations and adjustable font sizes. Classes are customized depending on student needs.
- 3) The assigned COIC teacher is available by message (Odysseyware and AZTEC), phone, text, and Zoom video during the school day for instruction and help.
- 4) School year starts with virtual orientation for parents and caregivers so that all understand the virtual tools and procedures.
- 5) The cohort data are current. This model establishes a process by which cohorts can set up, augmented, reduced, or quarantined.
- 6) The 12 Cohorts will roll over into the Hybrid Plan when conditions warrant.

General Plan

- 1) This plan is designed to work in tandem with Limited In Person Instruction (LIPI).
- 2) Essentially, each student is expected to work at home asynchronously with 2 weekly synchronous sessions either in person in the COIC classroom with a teacher and very small peer group or virtually off site. Applied learning experiences are assigned during this time with instructional support available.
- 3) Each assigned student will check in via phone, text, Zoom, Zoom chat, or some other acceptable method each school morning and afternoon.
- 4) Zooms will begin with an Advisory period to enhance engagement, mental social and emotional health.
- 5) Each cohort teacher grades and tracks attendance and school work completion.
- 6) Bend COIC Communicable Disease Management Plan describes details of the COVID-19 response.

LIPI Adaptation to Distance Learning

- 1) Intake occurs online. Parent communication schedule established.

- 2) GED Pre-testing occurs at home or individually in the COIC classroom dedicated for this purpose. Parent informed of results and related ed plan.
- 3) Cohorts strategically arranged by GED scores in Math and LA:
 - a) 13 cohorts, labelled B1 through B13, set up in the am and pm to meet Monday and Wednesday and Tuesday and Thursday. Attendance monitored per ODE and Bend La Pine guidelines. Although virtual class time is set up by cohort with a phone call, email, LMS, zoom, each session is open to any student with a specific question. Because of the small cohort size, this will not be disruptive.
- 4) No scheduled synchronous learning on Friday – teacher office hours from 8:30 – 3:30 or by arrangement. Office hours to deal with individual tutorials or parent meetings. Students are expected to work on asynchronous and applied learning activities.
- 5) Tight adherence to timetables.
- 6) GED testing will occur on-site in Bend. COIC is now authorized to administer the official GED Exam.

Describe the school’s plan, including the anticipated timeline, for returning to Hybrid Learning or On-Site Learning consistent with the *Ready Schools, Safe Learners* guidance.

On February 16, COIC Bend will transition from CDL – LIPI to a Hybrid model using a process that will allow fluid transition back to CDL – LIPI if the situation warrants. Essentially, under LIPI, each teacher has four cohorts: Monday-Wednesday am; Monday-Wednesday pm; Tuesday-Thursday am; and Tuesday-Thursday pm. LIPI cohorts do not exceed 10. Under the Hybrid, the am cohorts combine and the pm cohorts combine so that each teacher has two cohorts that do not exceed 20.

The remainder of this operational blueprint is not applicable to schools operating a Comprehensive Distance Learning Model.
